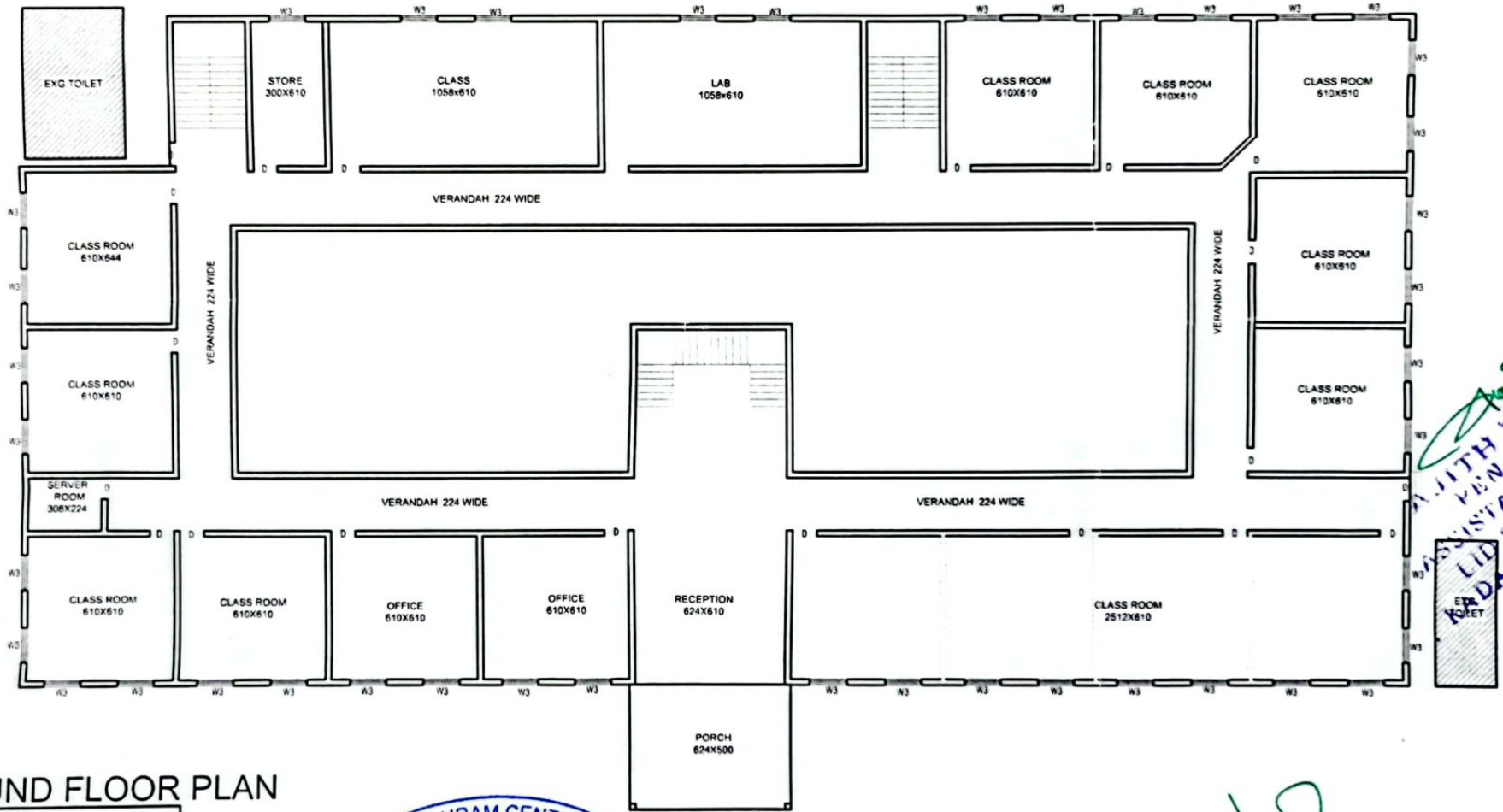

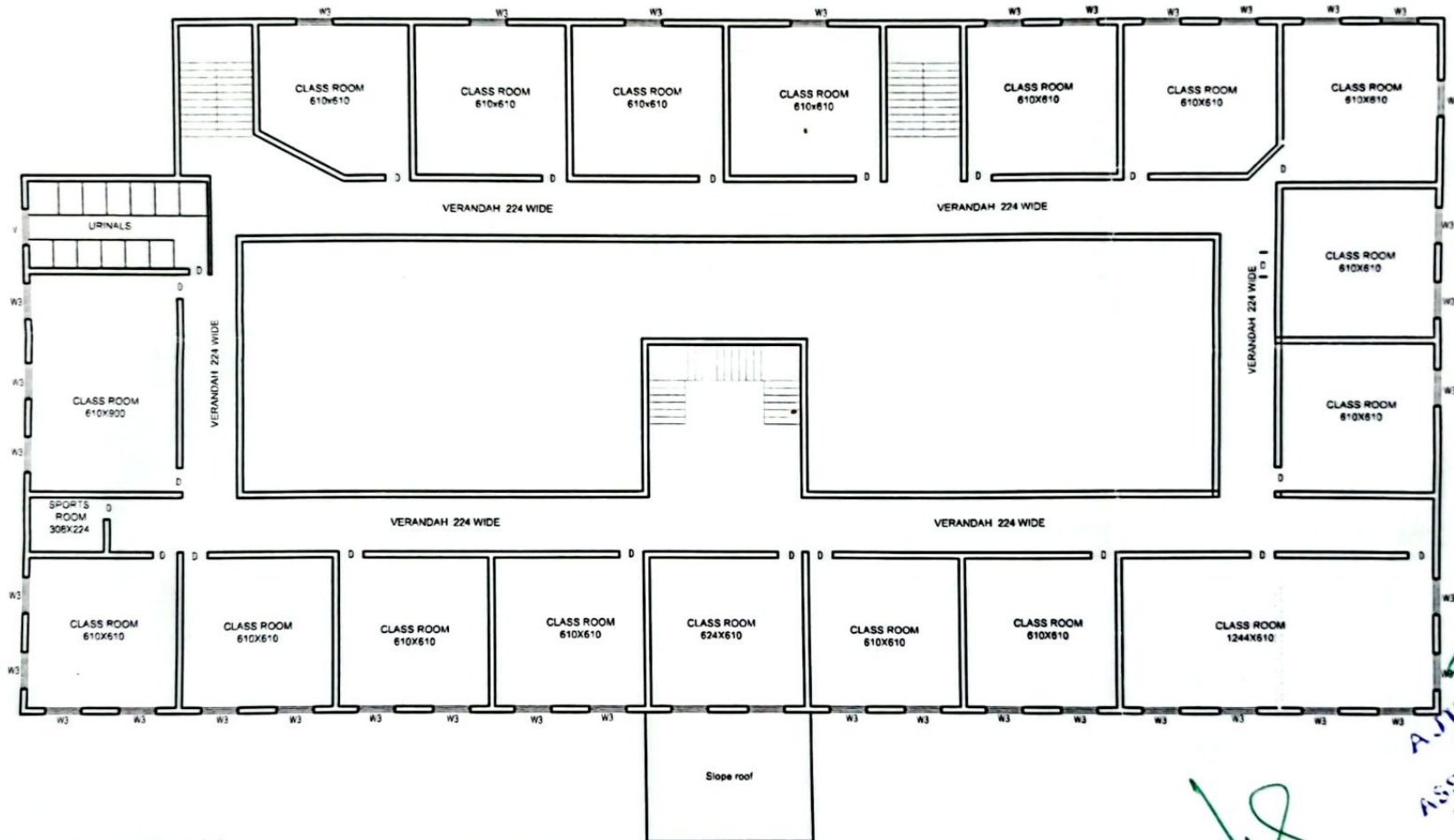

FIRST FLOOR PLAN

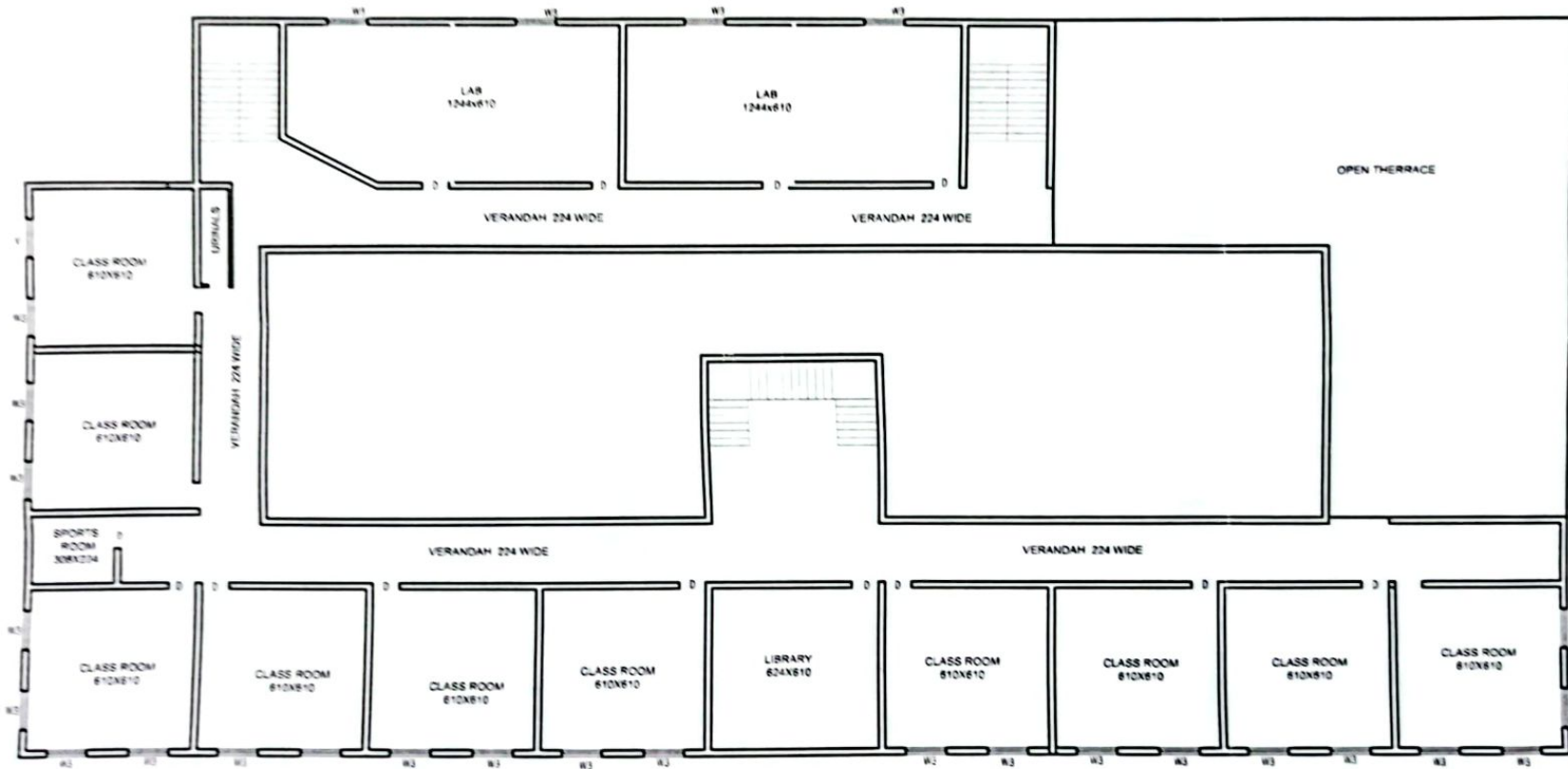
